ACCOMPLISHMENTS OF THE MONTH

Hiring/Organization

Our History Programs Manager position was open and recently closed. We hope to have the new manager in place by mid-August.

Interns: we hosted three student internships this summer, including college students from Whitman, Boise State University, and College of Idaho. One student worked in the History Division, and the other two served as the primary tour guides for the City Steps program over the summer, as well as creating content for two new tours that we will roll out in the next tour season.

Professional Development

Danielle Grundel and Jennifer Yribar each attended conferences in their fields, while other staff members attended online courses and webinars to continue building their skills, including the Smithsonian Education Conference. I will be attending the Western History Association Conference in October and moderating a panel on the history of redlining.

Commission Revision Updates

We have collated and reviewed the valuable feedback you provided during the information sessions.

We would like to make recommendations to the Mayor and City Council regarding the structure of the Commission and the ordinance which governs its existence by September. With Mayor's approval of the recommendations' general direction, we will work to amend the ordinance which governs the Commission.

Therefore, we would like to discuss your thoughts and ideas regarding the following recommendations at the Commission meeting on August 7.

Recommendations may include many of your excellent suggestions. Some of these may be referenced in the Commission's bylaws, while some may be incorporated into the revised ordinance. These recommendations may include:

- 1. Clarify role of commission as advisory in nature;
- 2. Provide an annual schedule of opportunities to serve, presented early in calendar year, with sign ups presented on a shared document;
- 3. Outline clear roles, responsibilities, opportunities, and expectations for commissioners;
- 4. Increase Commission size to 15, plus one student commissioner for a total of 16;
- 5. Hold meetings every second month;
- 6. Advise staff to continue providing updates via pre-meeting memos;
- 7. Adopt a committee structure resembling one of the following two options (or some combination thereof):
 - a) OPTION 1: Commissioners serve on at least one of three committees. Committee breakouts sessions could occur after every other commission meeting to discuss upcoming needs. Potential committees, whose membership would rotate annually, include the following:
 - i) <u>Ambassador Committee</u>: This committee will help Arts & History spread the word about its events, calls for artists, and other opportunities, and will serve as department ambassadors at events that are sponsored by or hosted by the department. **ATTN**: Funds will be available to reimburse Ambassadors for some event costs. Roles include:
 - (1) Attend department and grantee events, wear nametags, and announce the events on behalf of the department and the city when appropriate (in coordination with staff).
 - (2) Provide feedback to staff after events via a simple form, provided by department staff.
 - ii) Outreach Committee:
 - (1) Work with staff on creating and working with docent group;
 - (2) Work with staff on tour content and ideation;
 - (3) Assist with giving tours during tour season;
 - iii) <u>Panel Committee</u>: This committee's members will be responsible for filling the "commissioner" seat on all the department's selection panels. Staff will provide a signup sheet early in the calendar year, with time commitment and start and end dates clear. Role will include:
 - (1) Equally sharing in selection panel needs;
 - (2) Reviewing applications for grants as well as for public art projects;
 - (3) Attending selection panel meetings.
 - b) OPTION 2: Commissioners serve on a designated number of selection panels; attend a certain number of events as ambassadors; and participate in docent management and tours annually. Committee breakouts could occur after every other commission meeting to discuss upcoming/unanticipated needs.

For now, we will maintain our current schedule of bi-monthly meetings and will continue to provide informational memos. The information contained in staff memos will aim to



provide the commission members with clear calls to action based on the three committees.

General Fund Public Art Projects

Boise Depot 100 Anniversary Projection

\$50,000; Call is open for digital projection art for temporary display on the Boise Depot across 4 days. Selected artist will collaborate with a contracted projection professional, work with staff on a community engagement opportunity, and develop artwork for display that varies daily. Artwork will be displayed during the Boise Depot Centennial celebration event from April 13, 2025 – April 16, 2025.

ACCOMPLISHMENTS OF THE MONTH

Foothills Learning Center

Four site-based artworks located at the Foothills Learning Center were repaired on July 3rd. The repairs included sealing the mosaic tile grout of "Catface Revival" (2011) by Reham Arti. Removal of crayon wax from "Medicine Wheel" (2013) by Marianne Konvalinka and Lynn Fraley. Application of a clear protective coating to "Aero Agroseries" (2008) by Mark Baltes. As well as wall repair and acrylic in-painting of the "Foothills Mural" (2006) by Ward Hooper.

Memoirs of Erma Hayman

"Memoirs of Erma Hayman" (2022) is a site-based bas-relief series mounted on the exterior retaining wall at Erma Hayman House. The artist, Vinnie Bagwell, and her fabricator agreed to replace one of the bas-relief panels which exhibited hairline cracks throughout. The new panel arrived at City Hall and was installed June 10th.

Idanha Canopies

The "Idanha Canopies" (2003) by artists Nina and Berry Yankowitz will undergo inspection of the four concrete footings in July. This maintenance project is funded by CCDC as part of the T4 partnership agreement.

Artwork Transfer & Rotation

Four (4) framed 2D artworks have been transferred from the Boise Main Library into the permanent care of the Public Art Collection. The transfer is in concert with the upcoming remodeling of the Main Library.

Party Animals

Three (3) of the "Party Animals" (2013) by Reham Aarti have been deinstalled from the Boise Zoo due to construction at the Boise Zoo as well as to undergo repairs. The

sculptural mosaics were transported by the Cultural Assets team to City Hall for repair and will be returned to the Zoo after construction is complete.

History in Motion – Rubber Ground Installation

The large sculpture located in Catalpa Park titled "History in Motion" (2003) by Mark Stasz, has been improved with the installation of a new rubber bark ground surrounding the artwork. Installation of the rubber mulch was completed in June.

Mayor's Wall

The Cultural Assets team updated two (2) portraits of the Mayor installed on the "Mayor's Wall" (2016) by Byron Folwell located on the 3rd floor of City Hall.

Vox Poplar ADA Compliance

City of Boise Facilities Services & Operations installed a cane rail and cover guard on "Vox Poplar" (2017) by Janet Zweig. The mixed media interactive sculpture located at the Library at Bown Crossing required the noted improvements to comply with ADA standards.

Arts & History Division Strategic Planning

In line with our department's overall internal strategic plan, I am working with each division to build out division strategic plans. These center on the division's mission, vision, and goals. These are internal governing documents and will be highlighted in the upcoming revision of the Cultural and Creative Industries Master Plan. We've completed plans for all but two divisions, to be done in August.

2025-35 Cultural and Creative Industries Master Plan Update

Planning in process for undertaking the planning process. We will be conducting a survey with individual artists facilitated by Dr. Amanda Ashley in partnership with BSU. In the fall we will also be conducting focus groups, interviews, and potentially additional surveys to reach arts organizations and the public.

General Fund Public Arts Master Plan

I'm evaluating the existing conditions and future investment priorities for Boise's General Fund public art program. I've completed an analysis of the Library and am currently working with the Parks Department, conducting interviews, analyzing locations of existing public art, and identifying gaps in service.

Community Outreach:

• In June the City of Boise hosted a Welcoming Ceremony for the Return of the Boise Valley People. The Mayor's Office led the effort this year, while I provided even support.

Note: The Idaho Commission on the Arts is *not* moving forward with a Cultural District Program, so we are not conducting planning around this topic area.

Grants Program

Annual A&H Grant

We closed the annual Arts & History Grant funding opportunity on June 14 and received 54 applications. The community-based panel met on July 25 to review, score, and make recommendations for awards and funding amounts. Funding supports people in established and emerging cultural fields with projects designed to benefit the Boise residents with awards between \$1,000 and \$5,000 totaling \$150,000 annually. Learn more.

Catalyst Grant

We closed Round 3 of the Catalyst Grant and awarded the following applicants:

- Boise Hive for the Rap America Project.
- The Foundation for Idaho History for hosting 13 Stories Film Competition and Showcase.
- Pendulum Early Music* for a concert of music written for baroque violin, cello, viola da gamba, and harpsichord.
- Rebecca Evans* for writing sessions at the Women's and Children's Alliance.
- Under the Trees Boise for hosting two all-ages electronic music popups in Boise parks.

We also opened the fourth and final round of the Catalyst Grant. Applicants can submit proposals through August 2 for a standard award size of \$2,000 for projects that take place within Boise City Limits before September 30, 2024. <u>Learn more</u>.

Boise City Writer-in-Residence

 - a. Informational Item: 521 Public Space Public Art Proposal Stephanie Johnson
 - Background: Public art as a way a create placemaking. The collection includes Site-Based Installations, Traffic Boxes, Boise Visual Chronicle, Portable Works, as well as temporary opportunities. Nearing 1000 pieces of work.
 - ii. 521 W Grove St. Background of Project: In partnership with Parks & Rec, and CCDC. To be refunded by CCDC. Project initiated in 2023 with artist selected in 2024 after selection panel. In the application, asked that art would represent the many immigrant people who live in the area and who's stories aren't often represented.
 - iii. Reviews selection panel role and responsibilities, and selection criteria and rubric.
 - iv. Artist: Hua Design Studio. Based in California. At the heart of their collaboration, they honor the complex process of placemaking and place keeping; weaving together stories of migration, belonging and community resilience.
 - 1. Visited Boise and completed research and development of their final design.
 - v. Picked three elements to incorporate.
 - 1. Representing 9 different cultural groups, that have historical impact on the area. Using sandstone from a local quarry.
 - 2. Shade structure. Activated and powered by wind and will cast moving shadows.
 - 3. Brass mountains that will be lit up at night.
 - vi. Next Steps Before Installation: Artist will consult with a professional conservator and the Care & Conservation team to make sure the project is as durable as possible. Will consult with a structural engineer before fabricating. Installation planned for spring of 2025.

- Stevens Original budget was for \$400,000 but parts of the piece were not included in the original artist scope, rather the construction of the park and those are being moved under the cost of the projects. So in total CCDC will be covering \$700,000 for the piece.
- ix. Thom Can you speak more about what will be built in the space next to the park
 - 1. Stevens That discussion will happen when a developer brings the idea to Council
- x. Thom Is there parking?
 - 1. Stevens There will be street parking and a parking garage nearby
- xi. Clegg Really impressed with the design of this and all the work the artists have completed on this project
